Introduction

Digital technologies underpin all areas of society and the economy, from work to leisure to political participation. However, as technological developments in the field of digital and data science accelerate, balancing the rights of citizens while investing in the possibilities afforded by digital technologies remains tricky for legislators, policy makers, and the private sector alike. New technologies emerge and create new challenges even as organisations and governments struggle with creating appropriate responses for today. Challenges in digital policy arise for numerous reasons, across all sectors, and evolve

quickly. It is often the case that those with the knowledge and skills to develop new technologies are not aware of the broader implications of these new technologies. On the other hand, those tasked with developing, implementing, and evaluating governance and policy in the digital arena are not familiar with the ways in which technologies evolve or their potential effects and consequences. The universe of complex digital technologies is vast; there is no simple "one shot fix" that can govern all technologies. Our interdisciplinary Digital Policy programmes, that flow from content developed at our UCD Centre for Digital Policy, are designed to offer graduates the opportunity to study some of the core topical, theoretical, and methodological issues that arise today.

Programme Highlight

With support from Microsoft Ireland, UCD's School of Information and Communication studies presents the Microsoft-UCD Digital Policy Programme with the goal of building digital policy training and capability.

Our Graduate Diploma course and MSc course, in addition to related initiatives, will build on existing expertise and infrastructure across government, industry, civil society and academia to address the increased demand for digital policy knowledge and skills.

Elizabeth Farries Assistant Professor Programme Director

Dr Farries is a lecturer in the school of Information and Communities Studies and programme director of the MSc, Graduate Diploma and Professional Certificate programmes in Digital Policy. Co-director of the UCD Centre for Digital Policy, and a senior fellow with the International Network of Civil Liberties Organizations. She is a qualified lawyer in Canada and a member of the Law Society of British Columbia. She is a member of several public interest boards and working groups.

Elizabeth's research lies at the intersection of new technologies and regulation. She has a particular interest in digital policy cycles and assemblages emerging in the Digital Transformation. Her related research interests include gendered safety online, secure and private online communications, digital identities, as well as policing surveillance technologies, pandemic technologies, data retention and protection, and international intelligence sharing. She considers these topics in relation to technological impacts on vulnerability and special interest communities.

Applicant Profile

- Applicants should present with a primary (bachelor's) degree in any subject with an overall score of 2.1 or higher.
- Names and contact details of two referees who can assess their intellectual ability, maturity and motivation.
- Applicants whose first language is not English must also demonstrate English language proficiency of IELTS 6.5 (no band less than 6.0 in each element), or equivalent.
- While applications are accepted up to August of the year of entry, offers are made to suitably qualified candidates on a first-come-first-served basis. Early application is recommended as entry to the programmes is very competitive and the number of places is limited.
