Introduction

With support from Microsoft Ireland, UCD's School of Information and Communication studies is establishing the Microsoft-UCD Digital Policy Professional Certificate and the UCD Centre for Digital Policy with the goal of building digital policy training and capability in Ireland and Europe. The innovative programme mixes the applied and the abstract. It introduces students to basic concepts and issues in digital policy while also providing a crucial historical and critical understanding of digital policy developments.

Concepts covered include platform capitalism and governance, artificial intelligence, child protection online, online safety, cybersecurity, data infrastructures, information analytics, interface critique and software studies, among others. The Professional Certificate in Digital Policy is designed to prepare graduates for careers in government, non-governmental organisations, and technology industry in Ireland and internationally. The programme is built around stakeholder engagement and it will allow students to successfully expand their network of career opportunities internationally.

Programme Highlight

The course will take a multi-disciplinary approach to investigating the institutional and public policy dimensions of the prevalence of digital technology, as well as the underlying social conditions (economic, political, and cultural) and public/private sector contexts that give rise to such technologies and their governance.

Content will include lectures and hands-on exercises by academics, representatives from digital industries, and representatives of civil society.

Programme Content and Structure

Knowledge and understanding

- Understand both theoretical and applied issues in digital policy
- Demonstrate advanced conceptual knowledge of digital technologies and their implications for sociopolitical life
- Understand the dilemmas and tensions involved in regulating digital technologies

Applying knowledge and understanding

- Critically appraise evidence from research papers concerning topics in digital policy
- Critically evaluate existing digital policies and policy proposals and their limitations

Making judgements

- Systematically analyse the research literature in a key area of digital policy as part of their dissertation
- Decide, under guidance, on appropriate methodology and materials to be analysed for their dissertation

Communications and working skills

- Articulate theoretical concepts, current debates and research findings to both specialist and nonspecialist audiences from a digital policy perspective
- Work effectively with peers in learning, research, and presentation

Applicant Profile

- Applicants should present with a primary (bachelor's) degree in any subject with an overall score of 2.1 or higher.
- Names and contact details of two referees who can assess their intellectual ability, maturity and motivation.
- Applicants whose first language is not English must demonstrate English language proficiency of IELTS 7 (no band less than 6.5 in each element), or equivalent.
- While applications are accepted up to August of the year of entry, offers are made to suitably qualified candidates on a first-come-first-served basis so early application is recommended. Entry to the programmes is very competitive and the number of places is limited.

Digital Policy is in demand due to the growing impact and transformative powers of digital technologies on societies, businesses, economies, and the environment. It is a skill requirement for the future because the design and impacts of new digital technologies are developing at a rapid pace creating the need for new capabilities amongst private and public sectors around the world
