### Introduction

With support from Microsoft Ireland, UCD's School of Information and Communication Studies has established the Microsoft-UCD Digital Policy Professional Certificate with the goal of building digital policy training and capability in Ireland and Europe.

The programme advances an understanding of Digital Policy - a term that broadly encompasses regulation of new technologies including AI, Internet, Data, Media, and Communication Technologies Regulation - for those already in or seeking to expand their knowledge of the area.

The Professional Certificate is designed to prepare graduates and those seeking to upskill and enhance their expertise for government, non-government and technology-based careers in Ireland and internationally via hybrid (synchronous online and off) lectures, adaptable learning opportunities and engagement with industry-based stakeholders.

The Certificate also opens further education opportunities, such as the School of Information and Communication Studies' MSc/Graduate Diploma in Digital Policy.

# **Programme Highlight**

The programme welcomes regular stakeholder engagement and interaction, with guest speakers from the tech, industry and civil society, allowing students to successfully expand their networks and career opportunities.

Content will include lectures, class discussions and hands-on exercises.

Lectures are delivered both online and on campus, providing a hybrid and adaptable learning environment.

- Evaluate existing digital policies and policy proposals and their limitations
- Systematically analyse key research and literature on digital policy
- Develop methodological skills for analysis and evaluation of data and information
- Engage in independent and collaborative research and analysis with peers, educators and stakeholders
- Collect or source data using research methodologies taught on the programme

#### Communications and working skills

- Articulate theoretical concepts, current debates and research findings to both specialist and non-specialist audiences from a digital policy perspective
- Work effectively with peers in learning, research, and presentation
- Increase employability prospects by networking with government, industry and non-governmental organisations in Ireland and internationally

#### Student Requirements and Engagement

- 24 lecture hours over semester
- 100 autonomous research hours over semester
- Students are assessed via a practical skills assignment and essay

# **Applicant Requirements**

- Applicants should present with a primary (bachelor's) degree in any subject with an overall score of 2.1 or higher.
- Names and contact details of two referees who can assess their intellectual ability, maturity and motivation.
- Applicants whose first language is not English must demonstrate English language proficiency of IELTS 7 (no band less than 6.5 in each element), or equivalent.
- While applications are accepted up to August of the year of entry, offers are made to suitably qualified candidates on a first-come-first-served basis so early application is recommended. Entry to the programmes is very competitive and the number of places is limited.
