

Our Centre Membership continues to grow, drawing on multidisciplinary expertise in media, communications, law, politics, and computer science.









January 2024 Highlights

17 January: Centre Members Dr Susan Leavy and Dr Abeba Birhane were appointed to the Irish Government's Al Advisory Council, marking an important step in their contributions to Al policy and governance.

26 January: A <u>submission on disinformation</u> was presented to the Joint Oireachtas Committee on Tourism, Culture, Arts, Sport, and Media. The submission addressed current understandings of disinformation in the literature, the limitations of media literacy as a solution, and offered five key recommendations, including the implementation of monitoring and transparency measures and promoting a society-based approach beyond regulation.

18 January: Dr Abeba Birhane and Dr Elizabeth Farries contributed to an <u>Oireachtas submission on Policing Facial Recognition Technology</u>, focusing on ethical, legal, and practical concerns related to its use.

24 January: The Digital Policy II class commenced, held every Wednesday from 2-4 pm, continuing the Centre's educational efforts in the field.

6 February: We welcomed our first visiting fellow, <u>Hunter Vaughan</u>, a Senior Research Associate at the Minderoo Centre for Technology and Democracy at the University of Cambridge. Dr Vaughan's research focuses on the intersection of film and environmentalism. He is the author of *Hollywood's Dirtiest Secret: The Hidden Environmental Costs of the Movies* (2019) and coeditor of *Film and Television Production in the Age of Climate Crisis* (2022). Additionally, he is the founding editor of the *Journal of Environmental Media*, co-Director of the AHRC-funded Global Green Media Network, and co-PI of the Sustainable Subsea Networks project.

New Adjunct Assistant Professors: We are pleased to announce that Ronan Costello and Siobhan Cummiskey have joined the School of Information and Communication Studies as Adjunct Assistant Professors, bringing valuable expertise to our academic community.



28 March: A workshop was held with the Irish Council for Civil Liberties, focusing on the implications and challenges of Facial Recognition Technologies (FRTs). The #IDoNotConsent campaign continued to develop, advancing efforts to raise awareness and drive action on digital rights and privacy issues.

16 April: Professor Eugenia Siapera and Dr Elizabeth Farries presented at the PGMT (Postgraduate Media and Technology Conference) on the role of civil society organizations within platform governance frameworks.


18 April: The Al Primer Series was launched, offering foundational insights into artificial intelligence and its implications.



FORSEE Project

The Centre for Digital Policy at University College Dublin (UCD) has received €3 million in funding from Horizon Europe for the <u>FORSEE Project</u>, which focuses on artificial intelligence (AI) and its various implications on society. The project seeks to evaluate AI's effects on critical areas such as sustainability, labour, economic efficiency, gender equality, and civil society engagement. With the leadership of Dr Elizabeth Farries, the initiative aims to develop strategies that enhance the role of AI while addressing the societal challenges associated with its growth.

The FORSEE project is a collaboration among eight institutions across the European Union, and it intends to improve the understanding of Al governance. The goal is to ensure that Al development is ethical, inclusive, and aligned with European values. By focusing on both Al's technological advancements and the regulatory frameworks needed to guide them, the project aims to bridge gaps between innovation and its real-world implications in various sectors.

One of the key objectives of the project is to develop sustainable, equitable strategies for AI governance in Europe. It will engage with diverse societal stakeholders to ensure that AI systems are developed and regulated in ways that benefit all sectors of society. The project will contribute to shaping future policy on AI by generating empirical research, which will inform the design of regulations and strategies that address challenges and harness the full potential of AI.
